Last year VSA donated \$1000 for similar goals purchases. The Tree Farm is wondering if VSA can donate \$1000 this year?

- Background Checks
  - VCIC Timeliness 40 hrs. / Perhaps we should move this to the office and set it up with Gotsport to notify office personnel when a newly registered coach is entered. This can trigger the automatic National Check but also allows VSA to run VCIC immediately so member clubs can get answers guicker.
- Notifications of negative results Some clubs have inquired about being notified if ANY things are found in the background. We currently do not inform clubs of a disqualifier just that they have not passed the background check.
  - VSA will do preliminary review, deeper reviews will need to be conducted by a club with applicant consent and club ownership of this action.
